Order on Board

<u>3.11.2023</u>

- Since a common issue is involved in the present bunch of writ petitions, they are heard together and disposed of by this common order.
- 2. Challenge in the present writ petitions is to the order dated 4.9.2023 passed by the State/Respondent, whereby the amended posting orders of the Petitioners issued by the concerned Divisional Joint Directors have been cancelled.
- According to the pleadings of the writ petitions, the Petitioners, who were working as Assistant Teachers/Teachers, were

considered for promotion to the post of Teacher/Headmaster. After granting them promotion, as per the guidelines dated 29.3.2023, counselling was conducted and posting orders were issued. Thereafter. of some the promoted Teachers/Headmasters submitted applications praying for change in their posting after promotion and accordingly amended posting orders were issued by the concerned Joint Directors and pursuant thereto the Petitioners and other affected Teachers/Headmasters joined their new place of posting. However, vide the impugned order dated 4.9.2023, the State/Respondent cancelled all the amended posting orders of the Petitioners and other similarly situated Teachers/ Headmasters issued by the concerned Joint Directors holding that the amended posting orders issued by the authorities concerned are illegal and without authority of law. It was also directed that if any Teacher/Headmaster had joined at new place of posting on the strength of amended posting order then he/she would be relieved immediately to join at his/her original place of posting within a period of 10 days, failing which, his/her order of promotion shall stand cancelled automatically.

4. Learned Counsel appearing for the Respective Petitioners jointly submitted that pursuant to the amended posting orders issued by the concerned Joint Directors, the Petitioners and other affected Teachers/Headmasters have already joined at the place where they have been posted, their last pay certificates have also been sent there and they were also drawing salary there. It is further submitted that before passing of the impugned order dated 4.9.2023 no opportunity of hearing was afforded to the Petitioners. Hence, the impugned order is perverse and arbitrary. It is further submitted that even otherwise as per the Chhattisgarh School Education Services (Education and Administrative Cadre) Recruitment and Promotion Rules, 2019, the appointing authority of the Teachers is Joint Director. Therefore, the Joint Director is the competent authority and has jurisdiction to amend the place of posting of Teachers and, therefore also, the impugned order passed by the State is without jurisdiction. Hence, the impugned order is liable to be set aside. It is further submitted by the Learned Counsel that in the lead case, i.e., Writ Petition (S) No.6253 of 2023, this Court has passed an order on 11.9.2023 directing the parties to maintain status quo as was existing on that date. Thereafter, the Joint Director (Education) issued a letter to all the District Education Officers directing them not to accept joining of the Teachers/Headmasters who have been relieved to join at their respective place of posting prior to issuance of amended posting orders nor to allow them to join back at the place from where they had been relieved. Therefore, as of now, they are

not able to get any salary.

Per contra, Learned Counsel appearing for the Respondents 5. submitted that at the time of counselling the vacancies available with the Respondents were provided to the Petitioners and other promoted Teachers/Headmasters and after going through those vacancies they opted the places for their posting and accordingly the competent authority posted them. Thus, it is clear that posting of the Petitioners is made as per their opted place of posting and not as per the place given by the competent authority. It is further submitted that thereafter some of the Teachers/Headmasters did not join at their opted place and submitted applications seeking amendment in their posting orders and accordingly the concerned Joint Directors of five divisions passed the amended posting orders of the Teachers/Headmasters, which are 2723 in number as under:

6. It is further submitted by Learned Counsel for the

Respondents that after issuance of the amended posting orders, complaints were received by the State Government that the authorities have amended the earlier posting orders by obtaining illegal means. On receiving such complaints, the State Government conducted an inquiry into the matter through concerned Divisional Commissioners and on the basis of the reports of the Divisional Commissioners the impugned order has been passed. It is further submitted that the concerned Joint Directors have passed the amended posting orders without any authority. Since the amended posting orders were passed by the concerned Joint Directors during the transfer ban period, which is without co-ordination, the amended posting orders passed by the Joint Directors are illegal.

- 7. I have heard the rival contentions put-forth on behalf of the parties and perused the material available including all the documents annexed with due care.
- 8. Undisputedly, posting orders of the Teachers/Headmasters were issued after counselling and at the time of counselling also the Petitioners were given options for their places of posting. It is also not in dispute that after issuance of the posting orders, the Petitioners made applications for change in their place of posting and the concerned Joint Directors, on the basis of the said applications, passed the amended

posting orders and the said amended posting orders have been cancelled by the State/Respondent vide the impugned order dated 4.9.2023.

- 9. Considering the peculiar facts of the case and the submissions made on behalf of the parties, it would be appropriate to dispose of the present bunch of writ petitions without going into their merits by constituting a committee to consider and decide the matter of the present Petitioners. Accordingly, as proposed by Learned Counsel appearing for the parties, a committee is constituted comprising of the Principal Secretary of School Education Department as the Chairman, the Director of Public Instructions as a member and all the Joint Directors of the concerned five divisions as members of the committee (henceforth 'the committee').
- 10. Before the committee, all the applications of the Petitioners, which were made before the Joint Directors on the basis of which amended posting orders were issued, shall be placed. The Petitioners shall have liberty to submit any document in support of their said applications before the committee within 15 days from today. The committee shall decide the matter of each of the Petitioners and their fresh posting orders shall be issued by the committee or the competent authority. All these exercises shall be completed within 45 days from today. The committee or the days from today.

matter of the Petitioners and issuing their fresh posting orders, shall also consider relevant provisions of the transfer policy of the State dated 22.8.2022 and the directions issued by the State (School Education Department) dated 29.3.2023.

- 11. Considering the submissions made by Learned Counsel for the parties that pursuant to the orders passed by the concerned Joint Directors, the Petitioners have already joined at their place of posting and their last pay certificates have also been sent there and pursuant to the impugned order dated 4.9.2023 the Petitioners have already been relieved automatically from their place of posting and as of now pursuant to the order of this Court dated 11.9.2023 passed in the lead case, i.e., Writ Petition (S) No.6253 of 2023 they are not being allowed to join back at their previous place of posting and, therefore, they are not able to draw their salary, further considering the fact that pursuant to the impugned order the Petitioners have already been relieved automatically and in their places none have joined and, therefore, considering the interest of the students also, in the interest of justice it is directed that all the Petitioners be allowed to join at their previous place of posting so that their issue of salary could be resolved.
- 12. In view of the observations and directions made hereinabove,the impugned order dated 4.9.2023, so far as it relates to the

present Petitioners, is quashed.

- In the result, all the writ petitions are disposed of in the aforesaid terms.
